# PLANETXXI, LLC WEBSITE TERMS AND CONDITIONS

All visitors to and users of the PLANETXXI Website, planetxxi.com, (collectively "Users") are subject to these terms, which are subject to change at any time by our posting an amended, revised or different version on our website. By viewing, navigating or using the website, posting content or making a purchase or participating in any PLANETXXI activity or forum (any of these and all of them collectively are referred to as "Using the Website"), Users are agreeing to be bound by these terms, as amended, revised or in a different version. When Users are Using the Website they are also agreeing to comply with the terms of any third parties that PLANETXXI uses in the course of operating and maintaining the website or who otherwise provide services to PLANETXXI.

#### COMPLIANCE
